NOTICE OF RACE

1. RULES

- 1.1. The regatta will be governed by the rules as defined by the *Racing Rules of Sailing*.
- 1.2. RRS Appendix P will not apply.

2. ELIGIBILITY AND ENTRY

- 2.1. The regatta is open to boats meeting the requirements of the Club 420 class rules.
- 2.2. All competitors (both skipper and crew) must be current members of the Club 420 Association.
- 2.3. Individuals who will be twenty-two years or older in 2020 are not eligible to compete in this regatta.
- 2.4. Eligible boats may only enter by completing the online entry form and paying the entry fee before February 10, 2021 located at <https://theclubspot.com/register/regatta/n0GoUazuEV/class> All competitors must sign a "Release of Liability" ASSUMPTION AND ACKNOWLEDGEMENT OF RISKS, RELEASE OF LIABILITY AND REIMBURSEMENT AGREEMENT provided electronically when registering through Clubspot. Those competitors under the age of 18 must have their "Release of Liability" form signed by a parent or guardian.
- 2.5. No registration will be considered complete until all fees, required forms and signatures are received.
- 2.6. Registration will open for all competitors on **Friday November 13, 2020 at 0900 Eastern Standard Time.**
- 2.7. The regatta will initially be capped at 75 boats, after which time a waitlist will be formed. The OA and the Club 420 Class may choose to expand the regatta's size if health and safety conditions allow.

3. FEES

- 3.1. The entry fee is \$285 if received on or before Wednesday, January 13, 2021.
- 3.2. Entry fees are non-refundable on or after Wednesday, January 13, 2021. All refunds are subject to a 3% administrative fee.
- 3.3. A late fee of \$50 will be assessed for any entries received on or after 0100 on Thursday, January 14, 2021.
- 3.4. The entry fee includes a digital coupon for an event t-shirt.

4. SCHEDULE

- 4.1. Competitors may arrive at the USSCMC for practice and free access to the Sailing Center grounds and facilities up to 7 days in advance of the first day of racing.

- 4.3. **NO FOOD OR DRINK WILL BE PROVIDED TO COMPETITORS.**

4.4. A maximum of 12 races are scheduled.

5. MEASUREMENT AND INSPECTION

- 5.1. Every skipper must complete and submit a signed [Inspection Checklist](#) prior to participation in the regatta at check-in. These forms will also be available at the check-in desk.
- 5.2. All boats are subject to safety inspection at any time during the regatta.

6. SAILING INSTRUCTIONS

The sailing instructions will be available at check in and on the event website.

7. VENUE

- 7.1. The intended racing area will be East of the USSCMC on the Indian River Lagoon North of the Jensen Beach Bridge.
- 7.2. Attachment A shows the approximate location of the racing areas.

8. COURSES

A Trapezoid course will be run and will be published in the Sailing Instructions.

9. SCORING

- 9.1. The system in RRS Appendix A will be used.
- 9.2. One race must be completed to constitute a regatta. If the fleet is split into divisions, a race consists of all divisions completing a course with results that may be scored. This changes A2.
- 9.3. If more than 70 boats are registered, the fleet may be divided into divisions.
- 9.4. When fewer than five races are completed, a boat's series score will be the total of her race scores. This changes RRS A2.
- 9.5. When five or more races are completed, a boat's series score will be the total of her race scores excluding her worst score. This changes RRS A2.
- 9.6. If the Fleet is divided into divisions, there will be a Qualifying Round and a Championship Round attempted. If fewer than five races have been completed before the start of competition on the last race day, then the regatta will remain in the Qualifying Round format. If five or more races have been completed in the Qualifying Round before the start of the last day, there will be a Championship Round.
- 9.7. Scores from the Qualifying Round will carry forward into the Championship Round.

10. SAFETY

- 10.1. All competitors, parents, and coaches will be required to follow all local, county, state and federal regulations regarding health and safety. Additionally, the OA and Club 420 Class may choose to impose additional regulations at their discretion. These additional regulations will be posted in the form of an amendment to the NOR.
- 10.2. Parents/guardians/or competitors 18 or over at the time of the start of the event are responsible for the safety of the competitors. It is the responsibility solely of the parent(s) of the competitors, or in the instance of the competitor who is 18 or over, the competitor, to decide if the competitor should sail in the weather and sea conditions that might arise during the event. Parents of competitors under 18 not personally attending any part of the event must ensure that another adult is authorized and designated to make these decisions for their child.
- 10.3. Per RRS 40.1, all competitors shall wear either a US Coast Guard approved PFD, or a PFD approved by the country of their citizenship or residence, properly secured at all times, from dock to dock except when temporarily adding or removing clothing. Wet suits, dry suits and inflatable PFD's do not constitute adequate personal buoyancy. The 'Y' flag will not be flown.

11. COACH AND SPECTATOR BOATS (SUPPORT BOATS)

- 11.1. All *Support Persons* must register before racing begins and must always prominently fly a designated flag provided by the OA while in the water.
- 11.2. *Support Persons* are required to register online through Clubspot and pay a \$20 deposit for a support boat flag. Failure to return the flag at the end of the regatta will result in forfeiture of the deposit.
- 11.3. All *Support Persons* and spectator boats are considered safety boats and at the direction of the OA or race committee will render aid if requested per RRS 37.

12. PRIZES

- 12.1. Prizes will be awarded to first place through 10th place for Gold Fleet and first place through 5th place for Silver Fleet.
- 12.2. The top Junior team overall in which both skipper and crew are under 16 throughout 2021.

13. DISCLAIMER OF LIABILITY

Sailing is an activity that has an inherent risk of damage and injury. Competitors in this regatta participate entirely at their own risk. See RRS 4, Decision to Race. The race organizers (OA, Ratings Authority, Race Committee, Protest Committee, host club, sponsors, the Club 420 Association or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this race. By participating in this regatta, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

14. OTHER REQUIREMENTS

- 14.1. If a competitor under the age of 18 is not accompanied by a parent or legal guardian during all activities of the regatta, then the parent or legal guardian shall name a "Designated Adult" of 18 years or older, through entry in the online registration process and shall be present at all times in their absence and who will supervise the minor competitor at all times to assure his/her safety. This Designated Adult will accept full responsibility for all actions of the competitor during any activity related to the event. This includes on-shore activities before, during, and after the regatta.
- 14.2. For each competitor under 18, it is the competitor's parents, legal guardian or Designated Adult's decision to enter the regatta and to start or continue any race. The adult(s) supervising the competitors are ultimately responsible for the risks.
- 14.3. A competitor age 18 or older retains all responsibilities for himself or herself.
- 14.4. No contestant shall use, either on or off the water, alcoholic beverages (beer, wine or distilled spirits) or use any controlled substance (marijuana, cocaine, etc.) the possession of which is unlawful. This prohibition is in effect during the entire event, from date and time of arrival through date and time of departure from the St. Francis Yacht Club. Penalties for a violation of the prohibition may range from a reprimand to dismissal from the regatta. A hearing may be held in accordance with the RRS.

This Inspection List is not intended to replace or supplant the Class Rules of the Club 420 Association. In the event of conflict between this Inspection List and the Class Rules of Club 420 Association the latter shall govern.

1. The Skipper represents that he or she has not made any addition or alteration to the hull form, construction, equipment, type of equipment, placing of equipment, fittings, type of fittings, placing of fittings, spars, standing rigging, sails, battens and running rigging as supplied by a Builder except as allowed by the Class Rules. (Rule A.1.1) _____
2. 40 ft **Towline**, 3/8 inch in diameter, that floats, and is tied to the mast or bow shackle. The towing line shall be accessible on the deck within 6 inches of the bow stem at all times, including when capsized. Tape or velcro may be used to help secure the towing line to the bow deck or stem. (Rule C.4.3) ____
- 3A. If US Citizen or US resident: a **US Coast Guard approved PFD** will be used at all times while afloat. (Rule C.3.5) _
- 3B. If **Non-US Citizen** or non-US resident: a PFD approved by USCG or the country of competitor's citizenship or residence will be used at all times while afloat. (Rule C.3.5) _____
4. **Whistle** attached to PFD by lanyard long enough for competitor to use. (Rule C.3.6) _____
5. Boat has a line to keep **rudder** connected to boat in event of capsize or turtle. (Rule C.4.4) _____
6. Forestay (including any extensions which must be metal) is short enough to hold the front edge of the mast forward of the aft face of the mast partner when the jib halyard is released. (C.4.5) _____
7. Trapeze system, in addition to trapeze wire, has only one cleat, one or two sheaves, one handle and one ring on each side. (C.8.6) _____
8. Mainsail, jib and spinnaker were manufactured by the official Class Sailmaker and have the official Class patch. (C.9.0) __
9. If electronic, only a compass with heading, heading memory, and timing functions is permitted. Other electronic devices except a digital timing device, electronic compass, and a camera are not permitted to be carried on board while racing unless allowed in the NOR. (Rule C.3.8) _____
10. Skipper and Crew are current members of the Club 420 Class Association. (Rule C.3.0) _____
