## NOTICE OF RACE

### DATE, VENUE, ORGANIZING AUTHORITY, and O’PEN BIC ATTITUDE

The 2020 O’pen BIC/O’pen Skiff North American Championship “Un-Regatta” will be held at the USSCMC, March 27-29, 2020. The Organizing Authority for this regatta is USSCMC in association with the North American O’pen Skiff Class.

Important Event Introduction: The purpose of this event is to run a fun event for youth sailors in a more loosely competitive style in dynamic youth boats. Results are not nearly as important as everyone having a good time sailing. It is our goal that the sailors improve their skills, make new friends, exhibit first-class sportsmanship, and have a ton of fun. This event will be a combination of “conventional” style race formats with unorthodox “Un-Regatta” style courses and events. Don’t expect conventional windward-leeward racing or upwind starts for all races. Capsizes, freestyle, speed, and fun will be required. If you are a hard-core racer with rule book in hand, this event may not be for you. If you want to have fun, challenge your limits, and pioneer the new chapter in Youth Sailing, we invite you to come join the fun.

### ELEGIBILITY

The fleet is comprised of two Divisions. This modifies Class Rule C.2.3

- U13 Division: Competitors born January 1<sup>st</sup>, 2008 or there after
- Open Division (all ages welcome)

The number of races each day will be determined by the Race Committee.

Any changes to the start time will be posted on the USSCMC Notice Board by 7:00 pm of the preceding day. No warning signal will be given after 2:00 pm on Sunday, March 29th.

## **RULES**

The regatta rules will be outlined in the Sailing Instructions which may modify standard World Sailing rules, and the OBCA's Class Rules where applicable.

Boats may be required to display advertising supplied by the Organizing Authority.

## **HELMETS**

Protective helmets are required.

Forward WIP, cool O'pen Skiff sponsor, makes excellent sailing specific helmets.

Helmets are available for rent through the USSCMC for \$15 fee for the three-day regatta with a \$50 security deposit. Advanced reservations are required and may be done at the time of registration as an optional item.

## **ENTRY**

Go to <https://www.usscmc.org/regattas> for registration. Membership in the North American O'pen Skiff Class Association will be required. Membership can be made at USSCMC at check in.

## **ENTRY FEES**

The entry fee is \$150 (USD) per sailor, and includes regatta shirt, special social event, and Awards party. **Entry Fee will increase to \$185 (USD) on March 6, 2020.** Registration will close at midnight on Tuesday, March 24.

## **CHARTER BOATS**

A limited number of Charter boats are available from O'pen Skiff North America on first come/first serve basis. Please contact Nevin Sayre at [nsayre@aol.com](mailto:nsayre@aol.com) as soon as possible if you think you may need a charter boat and we'll get you on the list. All boats come complete and ready to sail and have fun with the One Design 4.5m sail. Here are the reservation options:

- Charter O'pen Skiff for North Americans - \$190.
- Purchase brand new O'pen Skiff, delivered to USSCMC for the event for \$2,600. No shipping fee or additional charter fees. You take ownership of the boat on delivery. Must be registered for 2020 North Americans to take advantage of this opportunity.

**The charter boat deadline for North Americans is Mach 6, 2020, but we will likely run out well before then.** Charter boats are available for sale at substantial discount following the event.

## **MEASUREMENTS AND CHECKS**

Boats, components, and sails must be in conformity with the O'pen Skiff Class Rules.

The Race Committee may check boats and crews before, during and after the races.

## **SAILING INSTRUCTIONS**

The Sailing Instructions will be available at <https://www.usscmc.org/regattas> prior to the event.

## **RACING FORMAT**

The number of races for all the Divisions will be at the discretion of the Race Committee.

Three valid races are required to constitute the championship.

There will be separate rankings for each age group division. At the discretion of the Race Committee, age groups may or may not be raced together as one fleet. At the discretion of the Race Committee, the fleets may be divided into smaller heats.

## **SCORING SYSTEM**

The Low Point scoring system of RRS Appendix A will apply.

There will be a discard race for every 4 races completed, i.e. one discard for 4 races, two discards for 8, 3 discards for 12, etc.

### **JURY**

On-the-water referees will be appointed by the regatta organizers. Their decisions will be final.

### **ADVERTISING**

Advertising is permitted as per O'pen Skiff Class Rules.

### **PRIZES**

Prizes will be awarded to the first 5 boats per division, and the top female in U13 & Open divisions.
