

Member Agreement

Welcome aboard! We are delighted you are a part of the US Sailing Center – Martin County (USSCMC) family. The USSCMC is a non-profit organization that owns and maintains over 85 boats. Members have no-charge access to the fleet after they successfully demonstrate necessary sailing skills and earn a rating.

The New Member Activation Fee includes a "sail-check" and a "facility tour." Both require scheduling an appointment by contacting the Sailing Center at office@usscmc.org or calling 772-334-8085.

Upon signing the Assumption & Acknowledgement waiver of liability, you also acknowledge and agree to abide by the following USSCMC membership rules.

As a USSCMC Member, I agree to the following:

Sail within my limits of skills and experience as it pertains to my choice of boats and sailing ability in current weather conditions or forecast for the day

Be responsible for ensuring **my guests sign a USSCMC Assumption & Acknowledgement waiver of liability** (available online and in the office) and submit the document to the office. I shall ensure my guests abide by all membership rules and terms of this agreement. The waiver is valid for one calendar year. Enforce that my guests will be with me on my boat and that they are not entitled to sail their own boat

I will **not charge any fees** to my guests.

I will **not bring any paid coach** or instructor as a guest without prior approval from the USSCMC Director.

I will be responsible for having an **emergency communications** device aboard while sailing (cell phone or marine radio), except when accompanied by a safety boat or sailing instructor.

I will set-up my member Rehub account and **sign out** my boat on Rehub before sailing. Likewise, I will sign in my boat after sailing. I will sail within my scheduled time and contact the office should I wish to remain on the water longer than my scheduled time.

I will keep my sailboat in the **membership sailing area** between the two causeway bridges (Jensen Beach & Stuart); unless approved by the Director and accompanied by a USSCMC Sailing Instructor.

I will be responsible for enforcing that everyone on my boat wears a lifejacket while sailing or paddling and ensure guests are wearing non-slip, protective footwear while sailing.

I will be responsible for **adequately rigging**, de-rigging, and returning all stored boat parts to their proper storage location. I will **ask for help** when I am unsure if I know how to properly rig, de-rig, or store sails or equipment.

I will document on Rehub any minor repairs or changes to the rigging that I have made during my visit for the day.

I will strictly abide by all maritime laws and right of way rules.

While on a USSCMC boat, I will remember that I represent the membership at large; therefore, I will always be a courteous boater.

I understand that use of **powerboats is not part of the USSCMC membership**. I recognize there may be **private boats** on the property that is not for membership sailing, so I will make sure that I do not use a private boat, dolly, or trailer.

I agree to ask when there is any reason to question if a boat is part of the membership fleet.

I understand that some boats on the property that the USSCMC owns are reserved for racing and/or charter use only and shall not be used for recreational use under my membership without approval from the USSCMC Director.

I understand that to check out a **Flying Scot or 16' Hobie Getaway requires an Adult or Family Membership**.

I will be helpful, **courteous, and respectful without being disruptive**.

I will not use profanity, ethnic slurs, or offensive language while on property.

I will **not encourage bullying** and **report** any suspected cases of adult and/or child abuse.

I will **not engage in sexual, religious, racial, or other harassment toward others**.

I will **not park in unauthorized parking areas** and will not park on the grass or sidewalk east of the roundabout.

I will be familiar with and abide by all posted rules and regulations of the USSCMC.

I recognize that **membership is a privilege** at the USSCMC; thus, the USSCMC has the right to refuse or terminate a membership. The USSCMC has created a safe, family-friendly atmosphere, where a spirit of cooperation abounds. If we observe or learn of anyone engaging in behavior detrimental to our mission or family atmosphere, we reserve the right to terminate that person's membership immediately. In such an event, we will provide a pro-rated refund.

We hope you enjoy your membership and your time on the water. Please keep in mind the Activation Fee is a one-time fee provided the membership is not allowed to expire.

**UNITED STATES SAILING CENTER OF MARTIN COUNTY, INC.
ASSUMPTION AND ACKNOWLEDGEMENT OF RISKS,
RELEASE OF LIABILITY AND REIMBURSEMENT AGREEMENT**

In consideration of being allowed to utilize the sailboats, kayaks or other wind or manually propelled watercraft, and other equipment, dock, site, building, and facilities (Amenities) of the United States Sailing Center of Martin County, Inc., also known as US Sailing Center* Martin County (hereinafter referred to as "Sailing Center"), and/or to participate in the Sailing Center programs, regattas, clinics, camps and activities (Programs), the undersigned, on behalf of himself/herself and his/her minor child(ren) who utilize the Amenities and/or participate in the Programs, acknowledges and agree as follows:

1. To abide by the rules and regulations of the Sailing Center, including any COVID-19 related safety measures, and be respectful of the Amenities of the Sailing Center, treat them with care, and bring to the attention of the Sailing Center staff any damage or irregularities which are observed or occur during use.
2. To return all Sailing Center watercraft and equipment after use in the same condition as when taken out, ordinary wear and tear excepted, and to clean, secure, and stow the watercraft, sails, and equipment as directed.
3. To be financially responsible for damage caused to the Amenities by the undersigned or his/her child(ren) and to reimburse the Sailing Center for any loss related thereto.
4. To not use any Sailing Center motorboats unless authorized explicitly by Sailing Center staff on occasion by occasion basis, and to be otherwise respectful to staff and follow their directions.
5. The undersigned understands that the sport of sailing, sailboat racing, and boating, in general, involves risk. Injuries, illnesses, and diseases (including infectious diseases such as COVID-19) may occur. The undersigned agrees to take all reasonable precautions to minimize such risks, and inspect boats, watercraft, and equipment before use and not use any which appear unsafe. He/she agrees to operate all boats and watercraft safely and responsibly, to wear a personal flotation device (PFD), to have his/her child(ren) wear PFD's at all times while onboard boats and watercraft, and to ensure that any persons onboard a watercraft of which he/she is in control shall wear a PFD. He/she further agrees to wear non-slip protective footwear while on the Sailing Center grounds and while onboard a boat or other watercraft and to ensure his/her child(ren) and guests do likewise. If using their own boat or watercraft, the undersigned represents that such boat or watercraft is safe and seaworthy condition and if racing, it complies with its respective class rules.
6. The undersigned assumes all risks of use of the Amenities and participating in Programs, whether utilizing boats or watercraft of the Sailing Center or their own boat or watercraft, and waives any claim against the Sailing Center, its officers, directors, employees, agents, volunteers or members in the event of damage to their own boat or watercraft, or injury or death to the undersigned or his/her child(ren). In the event 911, medical or other responders are called to assist due to injury. All fees related to such services and hospital/medical care will be responsible for the person receiving the services or his/her parent(s)/guardian if a minor child.

7. The undersigned hereby releases the Sailing Center, its officers, directors, employees, agents, volunteers, and members from all liability to the undersigned and his/her child(ren) related to the utilization of Amenities or participation in Programs by the undersigned or his/her child(ren).

8. Special note regarding COVID-19. Risks under this Agreement include the potential for exposure to COVID-19, an extremely contagious virus that spreads from person-to-person contact. The Organization has taken preventative measures to reduce the spread of COVID-19; however, attending or participating in an event could increase your risk of contracting COVID-19, resulting in personal injury, illness, permanent disability, and death.

9. Registration, attendance at or participation in sailing regattas, lessons, clinics, summer camps, fundraising or social events, and membership or other activities of the US Sailing Center * Martin County whether on the premises of the Sailing Center, on the water, or at different locations, constitutes agreement to the use and distribution of the registrant's, attendee's or participant's image in photographs, video, and electronic media and the image of his/her registered, attending or participating minor children by the Sailing Center for educational and promotional purposes.

10. Participants are responsible for ensuring they have watercraft liability coverage for their privately owned vessel during an event or regatta at a minimum amount of (\$1,000,000.00) per claim and an aggregate amount of (\$2,000,000.00).

11. To ensure the safety of our young sailors, all adult members and volunteers are subject to screening through the Dru Sjodin National Sex Offender Public Website (NSOPW). This resource provides the public with access to sex offender data nationwide.
